4. Old Business

- **a. Review of Non-Profit Status:** John confirmed that our non-profit status is once again current and provided the certificate from the Secretary of State. EHLA's entity type is "Nonprofit Corporation for Mutual Benefit." By the Sec. of State and a "Civic League" by the Cal. FTB. Following this meeting, John was able to confirm that donations made to EHLA are not tax deductible.
- b. Discuss EHLA communique and date to send out. Not discussed this meeting.
- c. Any further discussion/actions for Neighborhood Watch, Cmty Emergency Response Trng, Fire Safety/Danger Classes, First Aid/CPR, Garden Tours (resume in 2023):
 - **i.** Eileen shared information on upcoming CERT training for this area. Cost is \$30/person an is tentatively planned for July 16/17 and 23/24 (4-day academy). Info will be posted to Lakeside Fire Protection Dist. Website once finalized.
 - **ii.** Kath shared info on CPR classes. Amer. Red Cross currently requires online portion completed followed by in person class for certification. There are a number of other providers. Classes range from \$35-50 per class and offerings include any one or combination of classes including: Basic Life Support (BLS), CPR, First Aide, etc. There is the option to attend an existing scheduled class in the community or an organization can

host a class. Regarding hosting, prices per person range on minimum number of people registered.

- d. Insurance Discussion-consider daily/one-time event coverage: Not discussed in this meeting.
- e. Bylaws:

Discussion: Updated to reflect 2020 Census in Article II.a. No changes with new census. Kath will add today's date to footnote and email to all.

Action: Richard motioned for approval, Bob seconded, all in favor, motion passed and bylaws approved.

We agreed that, in the future, we will try to get one scheduled much earlier in the year. For 2022, we will hold a chipping event as soon as possible and perhaps a second one this winter.
